

DOBCEL Policy Implementation and Timeline

On January 1st 2021, the DOBCEL Board received endorsement from VRQA to govern 56 schools within the Diocese. The VRQA requires all DOBCEL Schools to implement the policies and procedures (as listed) by mid 2021. All policies have also been ratified by staff from CECV and implementation will ensure consistency across all DOBCEL schools.

CEB acknowledges that the timeline is less than optimal, however, it will be necessary to ensure that DOBCEL meets its requirements to VRQA.

To support schools in this process:

- 1. On the date as shown below the Newsletter will indicate that the polices as listed will be available on eSORT.
- 2. Attached to the Newsletter will be a summary of the changes (if applicable) and the procedures required of schools for implementation. The summary sheet will also indicate the responsible CEB contact person, if there are any further queries relating to the policy.
- 3. Also attached to the Newsletter will be a brief video/overview explaining the requirements.
- 4. There will be an opportunity for a Q&A Session (date and time will be advertised).
- 5. We encourage you to share this information with relevant staff members to assist in implementing the DOBCEL Policy and Procedure

Schools will have two weeks to implement the policies from the date that they are detailed on the Newsletter.

It is advised that Principals outline this process to School Advisory Councils (SAC). The SAC can be engaged in the implementation process, however the SAC will no longer need to write or review policies.

CEB staff can support small schools – if support is required please contact your Education Consultant.

Please also note that once all policies have been implemented (mid June) that a policy review process will be outlined to ensure that all future policies and procedures are reviewed in a timely manner. This will include a consultation process and school representatives will have an opportunity to contribute. However, as the regulators (VRQA, Vic Gov't) make changes, we will need to comply. Therefore, there may be some changes that flow through, such as the introduction of the Information Sharing Scheme.
