**Step 1:** New users of this learning system need to register an account by choosing a username and password and providing personal details.


This information is required to create and maintain your user profile, including to keep a record of training that you complete.


**Step 2:** Please provide your contact so that you can be provided occasional updates about changes to law, policy and your professional and legal obligations.

If you select 'Email' as your 'Preferred Method of Contact' and 'Yes' to 'I wish to receive further information', you will receive a notification every 12 months to remind you to enrol in the training again to refresh your knowledge.

**Step 3:** Please provide your Department and Agency Information to help us report on statewide completion of the training modules.

Please select 'Department of Education and Training' as your Sharing Scheme Department. You will then need to select the most appropriate Workforce option, for example:

- · Independent schools and system bodies





**Step 4:** Please provide your Organisation details to ensure you are provided access to the appropriate training modules for your role.
